Dear Dr Eugene Pretorius

My cancer nightmare started round about Feb. 2005.

I still remember it very clearly when the doctor told me I have to make a plan to go for chemo. He said if I don't make a plan this thing is going to kill me, I was scared because of what people told me about chemo. After some time they convinced me, so I went to the hospital for treatment

Before I went for Chemo therapy they said I must first sign a treatment form before they could give me chemo therapy, this is because of the fact that chemo can give you all kinds of side effects. The list of side effects was long, it was scary. Of Course!, they wanted to cover them selves, what they don't tell you is how many patents die because of chemo therapy. Then the nurses started me on my first cycle of chemo they gave me chemo, for 5 days a week on and 2 days off then another 5 days on and 2 days off. This is what they would call a cycle, I had to take three. When I was about half way trough the first cycle I couldn't handle it any longer I felt that they were busy killing me I never felt so sick in my entire life. I told them I wanted to stop the treatment. They convinced me to carry on, so I agreed to go on. For the first few minutes I could handle it, and then something just snapped inside of me I pulled out the drip, I was finished I just couldn't handle it any longer. I stopped the therapy.

After a month I went back for blood tests my blood makers was normal. What I didn't know is that something was still growing inside of me, there were some tests that they didn't do. So I carried on with life.

After a year and 6 months I really started having some problems. I went back to the hospital and they send me for a CT scan. The doctor discussed the results of the scan with me and told me there was a growth under my intestines and it was big about 10cm x 16cm. Then the doctor told me they cant remove the growth because it still had cancer in it.

This was giving me a lot of pain and I took a lot of pain pills. I thought to myself I would rather take the pain than the chemo.

Then I got a lucky break my moms friend heard of a doctor on the radio that could help, he had a better treatment and more advanced treatment. My parents made an appointment for me to go and see Doctor Eugene Pretorius. At first I was skeptical and asked him a lot of questions. His treatment also involved chemo but in much lower quantities, he explained how his treatment worked. He told me that cancer lived manly on sugar and how he takes away the cancers food by a method of injecting insulin and in this way he can treat the cancer more effectively. He told me I am not going to suffer at all like with the chemo I received before. When he told me I was only going to be treated once a week I new I would be able to handle his treatment. I started treatment with Doctor Pretorius the 1st of April 2008 until the 19th of May 2008. He was right his, treatment was much less severe than what I was used to, I almost couldn't compare the two treatments. He send me for a pet scan and this time around the cancer was dead for sure. Only then Dr. L Coetzee was willing to remove the growth.

I had the operation done at the urology hospital in Pretoria. Dr Lance Coetzee did the operation and still send the growth for tests, it was cancer free.

In December 2009 I went for a follow up scan at the Urology hospital and I am still "cancer free".
